REGULAR MEETING OF THE CALIFORNIA STATEWIDE COMMUNITIES DEVELOPMENT AUTHORITY

September 7, 2023 at 2:00 pm

Commission Chair Brian Moura called the meeting to order at 2:00 pm.

1. Roll Call.

BACKGROUND AND SUMMARY:

The actions requested today by the Commission are the first steps in connection with 13 projects expected to be included in the SCIP 2023F pool. Attachment A includes a breakdown and location of the projects. The estimated amount of the SCIP 2023F financing is \$26 million. The Vineyards at El Dorado and Rosewood projects will be for formation only, and will issue bonds in a later SCIP pool.

An additional action is requested to change the hearing date from November 2nd to October 19th for the Dantoni Ranch projects whose ROI was approved on September 7, 2023. Dantoni Ranch is a community facilities district and does not require 45 days-notice. The October 19, 2023 date works better for projected homes sales relating to the project.

EXECUTIVE SUMMARY:

- CSCDA formed the Promenade at Sand Creek Community Facilities District (CFD) on August 18, 2022.
- The action requested today is to approve the first series of bonds for the Promenade at Sand Creek CFD located in the City of Antioch, County of Contra Costa California (the "City").
- The CFD funds are being used to finance public facilities and fees for the City.

BACKGROUND:

The proposed project consists of a residential development on 51.1 total acres, including up to 296 single-family residential. TriPointe Homes is the developer and one of the largest public homebuilders in the US. PURPOSE: Consideration of a Joint Exercise of Powers Agreement between CSCDA and the Hidden

Valley Community Services District

EXECUTIVE SUMMARY:

The Hidden Valley Community Service District (the "District"), located in Lake County, has requested that CSCDA enter into a new joint exercise of powers agreement, creating the Hidden Valley Community Services District Public Financing Authority, to assist with the financing of capital improvement projects and working capital for the District.

BACKGROUND & SUMMARY:

The District is interested in financing various capital projects within its boundaries. A bond financing is being considered and the bonds will be issued by a joint powers authority. In order to form a joint powers authority, the City needed to find an eligible public entity to be the counterparty to a joint exercise of powers agreement.

- After approval by District Board and the CSCDA Commission, the District and CSCDA will enter
 into the Joint Powers Agreement to form the Hidden Valley Community Services District Public
 Financing Authority (the "Authority"). CSCDA will have no other role in the proposed bond
 financing.
- The governing board of the Authority will consist of the members of the District Board. The administration and operation of the Authority will be provided by District staff.
- CSCDA will be the only other member to the Authority. Standard limitations on liability and indemnification are contained in the Joint Exercise of Powers Agreement between the District and CSCDA.

- CSCDA has previously entered into similar joint powers agreements to assist the San Bruno Park School District, Cameron Park Community Services District, San Dieguito Union High School District, Alameda County Flood Control and Water Conservation District, Zone 7, City of Orange, City of Martinez, West County Wastewater District, City of Dublin, Mountain House Community Services District, El Toro Water District, City of St. Helena and City of Laguna Beach in connection with similar financings.
- CSCDA will charge the City its standard facilitation fee of \$10,000.
- Stradling, Yocca, Carlson & Rauth are serving as bond counsel. CSCDA's General Counsel has reviewed the Joint Exercise of Powers Agreement.

RECOMMENDED ACTION:

CSCDA's Executive Director recommends that the Commission approve the resolution to authorize CSCDA to enter into the joint exercise of powers agreement by and between CSCDA and the Hidden Valley Community Services District .

SUBJECT: Local Governance Summer Institute at Stanford Sponsorship

BACKGROUND:

In 2021, 2022, and 2023, the Commission approved a sponsorship request of \$24,000 for the Local Governance Summer Institute at Stanford (LGSI) to provide four scholarships for local government executives. For 2024 LGSI has requested a sponsorship in the amount of \$30,000 to fund four scholarships due to the increase of tuition from \$6,000 to \$7,500.

Two of the 2023 scholarship awardees deferred their scholarships to the 2024 program. Thus, there would be two scholarships available to new applicants for 2024. It is recommended that at least one of the two scholarships be awarded to a county representative since the two deferrals are city representatives.

As a sponsor CSCDA would be provided the opportunity to participate on a panel discussion for the 2024 LGSI. The LGSI is supported by the League's City Managers Department, the California Association of County Executives (CACE), Cal-ICMA, and the California City Management Foundation. In addition, we would request that CSCDA logo be placed on materials associated with LGSI.

2024 Program:

The 2024 summer program consists of five full days of presentations and education. Tuition is \$7,500 per person.

RECOMMENDATION:

The Executive Director recommends that CSCDA provide \$30,000 in support for the 2024 LGSI Senior Executives Scholarship Fund, which will enable four local government executives to attend the 2024 program who would otherwise not be able to participate.
