MINUTES

ADJOURNED REGULAR MEETING OF DECEMBER 19, 2024

MEETING WAS ADJOURNED FOR A LACK OF A QUORUM. THE HEARING WAS POSTPONED UNTIL DECEMBER 23, 2024.

December 23, 2024 at 2:00 PM

Commission Chair Brian Moura called the meeting to order at 2:00 pm.

1. Roll Call.

2. Consideration of the Minutes of the December 5, 2024 Regular Meeting.

The Commission approved the December 5, 2024 Regular Meeting minutes.

Motion to approve by B. Stiger. Second by L. Moty. Unanimously approved by roll-call vote.

- 4. <u>Statewide Community Infrastructure Program (SCIP) District Proceedings:</u>
 - a. Conduct and close or continue consolidated public hearings with respect to the Statewide Community Infrastructure Program ("SCIP") for certain Assessment Districts (collectively, the "ADs") and Community Facilities Districts ("CFDs")

for multiple development projects to be included in a bond issuance for Series 2024C-2 or a separate pooled or stand-alone issuance.

Motion to close the public hearing by V. Chiesa. Second by K. O'Rourke. Unanimously approved by voice vote.

- b. Conduct following actions with respect to the SCIP ADs to be included in a bond issuance for Series 2024C-2 or a separate pooled or stand-alone issuance:
 - 1. Open assessment ballots of landowners within the ADs and announce the results.
 - 2. Consideration of resolutions approving final engineer's reports, levying assessments, ordering the financing of specified development impact fees and capital improvements, confirming the amounts of unpaid assessments and directing related actions in relation to the ADs.

Motion to approve by L. Moty. Second by B. Stiger. Unanimously approved by roll-call vote.

- c. Conduct following actions with respect to the SCIP CFDs to be included in a bond issuance for Series 2024C-2 or a separate pooled or stand-alone issuance:
 - 1. Consideration of resolutions of formation establishing the CFDs, each providing for the levy of a special tax therein to finance certain public improvements and development impact fees, as applicable.

Motion to approve by V. Chiesa. Second by L. Moty. Unanimously approved by roll-call vote.

2. Consideration of resolutions deeming it necessary to incur bonded indebtedness to finance certain public improvements either directly or to be constructed from certain development impact fees to mitigate the impacts of development within the CFDs.

Motion to approve by B. Stiger. Second by K. O'Rourke. Unanimously approved by rollcall vote.

3. Consideration of resolutions calling special mailed-ballot elections within the CFDs.

Motion to approve by V. Chiesa. Second by L. Moty. Unanimously approved by roll-call vote.

- 5. Consideration of resolutions declaring results of special mailed-ballot elections within the CFDs.

3. Consideration of resolution authorizing the issuance, sale and delivery of not to exceed \$29,009,650.18 of SCIP Revenue Bonds, Series 2024C-2 and approving the forms of a trust agreement, a bond purchase agreement, a continuing disclosure certificate, an official statement, and authorizing certain other actions in connection therewith.

Motion to approve by V. Chiesa. Second by B. Stiger. Unanimously approved by roll-call vote

5. Consideration of update to commercial PACE guidelines.

Motion to approve by B. Stiger. Second by V. Chiesa. Unanimously approved by roll-call vote.

6. Consideration of CSCDA 2023-24 FY Audited Financial Statements.

Executive Director Barna presented CSCDA's 2023-24 audited Financials, and projections for the upcoming year.

Motion to approve by B. Stiger. Second by V. Chiesa. L. Moty abstained. Unanimously approved by roll-call vote.

Executive Director Barna thanked Commission and partners for attending the farewell/ holiday dinner last week. The Ad Hoc Committee continues to work on background information for a presentation at a future Commission Study Session regarding the Program Management Agreement with Bridge Strategic Partners.

PURPOSE: Consider resolutions for certain SCIP Community Facilities Districts in respect of multiple development projects for Series 2025A or a future bond issuance.

BACKGROUND AND SUMMARY:

The actions requested today by the Commission are the first steps in connection with the below-referenced projects that are expected to be included in the SCIP 2025A pool. The request to form these districts early is based upon the fact that the first home sales for each project are closing prior to the district formation date for SCIP 2025A on April 17, 2025.

The three projects will result in the construction of 291 new single-family homes in the cities of Lathrop, Sacramento and Yuba. The total financed fees and improvements for all three projects is \$11,745,000.

The 2025A SCIP pool is estimated to be approximately \$66 million for 21 projects, which will be the largest pool in terms of number of projects and dollar amount since the inception of the program in 2003. The financing will result in an estimated 2,052 new single-family homes throughout California.

For consideration are the following resolutions:

1. Resolution approving joint community facilities agreements and declaring intention to establish each SCIP Community Facilities District, designate an improvement area therein and identify territory for future annexation, if applicable, and to levy special taxes therein to finance certain public improvements and fees and to levy special taxes therein; and

2. Resolution to incur bonded indebtedness to finance certain public improvements and fees within each SCIP Community Facilities District and calling for a public hearing on February 20, 2025.

Subsequent approvals of the financing will be brought back to the Commission at future meetings.

RECOMMENDED ACTION:

CSCDA's Executive Director recommends approval of the resolutions as presented to the Commission and setting the public hearing for February 20, 2025.

PURPOSE: Conduct second reading and adoption of ordinances levying a special tax within community facilities districts included in the Statewide Community Infrastructure Program Series 2024C-2 or a separate pooled or stand-alone issuance.

BACKGROUND AND SUMMARY:

The actions requested today by the Commission are the final steps to form the districts for the Huntington (City of Morgan Hill) and Four 40 West (City of West Sacramento) CFD projects expected to be included in the SCIP 2024C-2 pool. The Commission conducted the first reading of the ordinance and waived further reading at the December 23, 2024 meeting.

RECOMMENDED ACTION:

The action by the Commission is to conduct the second reading and adoption of ordinances levying a special tax within community facilities districts included in the Statewide Community Infrastructure Program Series 2024C-2 or a separate pooled or stand-alone issuance.
