PURPOSE: Consent Calendar

SUMMARY:

1. Consideration of a resolution confirming C-PACE related documents for Clearwater PACE.

Clearwater PACE is a new CSCDA Open PACE commercial PACE provider, and was approved by the Commission on February 20, 2025. The resolution approves the form documents that are used for the Open PACE program. Jones Hall as PACE counsel have drafted the forms, and they are consistent with what are being used for the Open PACE program.

2. Consideration of a resolution approving certain document amendments for Ivy Hill Apartments.

On June 6, 2017, CSCDA issued \$25,000,000 in tax-exempt affordable housing bonds for Ivy Hill Apartments, located in Walnut Creek, California. The borrower has requested certain document amendments that aim to incorporate modes for Fannie Mae, Freddie Mac, and bank letter-of-credit executions. The amended documents enable the existing debt to be more readily assumable by a prospective purchaser. Orrick, Herrington & Sutcliffe, as bond counsel, has prepared, reviewed, and approved the proposed document amendments.

3. Consideration of a resolution adding Felicia Williams, CSCDA Executive Director, as a CSCDA authorized signatory.

Felicia Williams is CSCDA's new Executive Director, effective August 1, 2025, and shall accordingly be a new authorized signatory for CSCDA.

4. Inducement of Fontana Courtplace I Housing Partners, L.P. (Fontana Courtplace I), City of Fontana, County of San Bernardino; issue up to \$15 million in multifamily housing revenue bonds.

Inducement of the proposed new construction of a 50-unit affordable multifamily housing project in the City of Fontana, County of San Bernardino. Application to CDLAC likely to be in 2026.

5. Consideration of resolution approving the addition of the City of Red Bluff as a CSCDA Program Participant.

City of Red Bluff City Council approved becoming a member on June 17, 2025.

PURPOSE: Public hearing and consideration of a resolutions for California Statewide Communities

Development Authority Community Facilities District No. 2025-2M (Ocean Breeze Ranch Maintenance), County of San Diego, State of California, and to levy special taxes therein

to finance certain public services.

BACKGROUND AND SUMMARY:

The Commission set the public hearing for today at the June 26, 2025 Commission meeting. The action requested today by the Commission is the second step in connection in forming a maintenance Community Facilities District (CFD) for the Ocean Breeze Ranch project in the County of San Diego. The CFD will consist of two planning areas that will be developed as 381 single-family residential properties.

On October 9, 2024, the County of San Diego (the "County") adopted a resolution to authorize CSCDA forming maintenance only CFDs on its behalf in order to lessen the administrative burden to the County.

Maintenance only CFDs allow for the levy of a special tax to fund ongoing maintenance of public infrastructure and services necessary to start development, and are independent of the bond financing (debt issuance) offered by the SCIP program. The Ocean Breeze project will participate in a bond financing in the future.

The County has reviewed and signed off on the documents associated with the maintenance CFD.

PURPOSE: Consideration of a Joint Exercise of Powers Agreement between CSCDA and City of

Kerman, County of Fresno.

EXECUTIVE SUMMARY:

The City of Kerman (the "City"), located in Fresno County is creating a new JPA and has requested that CSCDA replace the Kerman Redevelopment Agency as the other member of the Kerman Public Financing Authority (the "Authority"). The Kerman Public Financing Authority was formed on August 15, 2007.

BACKGROUND & SUMMARY:

In order to form a joint powers authority, the City needed to find an eligible public entity to be the counterparty to a joint exercise of powers agreement since the Redevelopment Agency was dissolved. No financings are in the immediate future, but the City wanted to have the Authority formed so it can proceed when ready.

- CSCDA will have no other role than being a member in any bond financing.
- The governing board of the Authority will consist of the members of the City Council. The administration and operation of the Authority will be provided by City staff.
- CSCDA will be the only other member to the Authority. Standard limitations on liability and indemnification are contained in the Joint Exercise of Powers Agreement between the City and CSCDA.
- CSCDA has previously entered into similar joint powers agreements to assist the San Bruno Park School District, Cameron Park Community Services District, San Dieguito Union High School District, Alameda County Flood Control and Water Conservation District, Zone 7, City of Orange, City of Martinez, West County Wastewater District, City of Dublin, Mountain House Community Services District, El Toro Water District, City of St. Helena, City of Laguna Beach, City of Santa Barbara, Hidden Lakes CSD, Laguna Beach County Water District and Paso Robles in connection with similar financings.

- CSCDA will charge the City its standard facilitation fee of \$10,000.
- Jones Hall is bond counsel to the City. CSCDA's General Counsel has reviewed the Joint Exercise of Powers Agreement.

COMMISSION ACTION:

Approve the resolution to authorize CSCDA to enter into the joint exercise of powers agreement by and between CSCDA and the City of Kerman.
