Commission Member Srivatsa called the meeting to order at 2:01 pm.

Executive Director Williams will be attending the November 6<sup>th</sup> meeting in-person at Cal Cities.

Staff will be sending out calendar invites for the 2026 CSCDA Regular Meetings.

Staff announced that there has been some movement with regards to some of the insurance companies being interested in being part of a potential new program, wild fire mitigation *PACE*.

#### **BACKGROUND AND SUMMARY:**

The actions requested today by the Commission are to initiate the first steps in connection with the six assessment district projects and one community facilities district expected to be included in the SCIP 2025C-2 pool. Two projects will be formation-only and included in a future SCIP pool.

The estimated total amount of the 2025C-2 SCIP financing is \$47 million, and will result in the construction 1,645 new single-family homes.

# FORMATION OF 2025C-2 ASSESSMENT DISTRICTS AND DELTA SHORES WEST COMMUNITY FACILITIES DISTRICT:

### **SCIP 2025C-2 Assessment Districts:**

- The resolutions for consideration today by the Commission are to initiate the first steps in connection with the six assessment districts that are expected to be included in the SCIP 2025C-2 pool.
  - o The SCIP 2025C-2 assessment district projects will create 468 new single-family units.
  - o The total amount of the financing for the assessment district is estimated to be \$18,370,000.
- The community facilities district formations will be brought to the Commission at the November 6, 2025 meeting.

• The public hearing for the assessment districts will be at the December 18, 2025 meeting.

## **Delta Shores West CFD:**

- The Delta Shores West project in the City of Sacramento is a 104 single-family unit project that is requesting an early formation because they will be selling homes prior to the SCIP 2025C-2 CFDs public hearing and formation.
- The public hearing for the Delta Shores West CFD will be at the December 4, 2025 meeting.
